Pittsburgh International Airport Contest Rules

(Updated 10.11.17)

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE WILL NOT IMPROVE ONE'S CHANCE OF WINNING. ODDS OF WINNING DEPEND ON THE NUMBER OF ELIGIBLE ENTRIES RECEIVED.

OPEN ONLY TO LEGAL U.S. RESIDENTS WHO ARE AT LEAST 18 YEARS OLD AS OF THE DATE OF CONTEST ENTRY. VOID WHERE PROHIBITED BY LAW. ELIGIBILITY RESTRICTIONS APPLY.

By entering this sweepstakes ("Contest"), entrants accept and agree to be bound by these official Contest rules ("Official Rules"). Any violation of these Official Rules may, in the sole and absolute discretion of The Allegheny County Airport Authority (the "Authority"), result in disqualification. The Authority will not make travel arrangements. Awardees must work with airline for details such as booking, ticketing and reservations. Winner has 30 days to claim prize or prize will be forfeited.

Any applicable airline or hotel rules may apply.

2. WHO IS ELIGIBLE TO PLAY

This Contest is only open to legal residents of the United States who are at least 18 years old as of the date of entry. Employees of the Authority, parent companies or subsidiaries, the Contest's participating sponsors and their advertising agencies, and members of the immediate family of any such persons are not eligible to participate and win. Potential Contest winners will be notified by email at the end of the Contest Period. If, despite reasonable efforts, any potential Contest winner does not respond within 72 hours of the first notification attempt with potential winner's complete name and phone number and/or email as provided, such potential Contest winner may forfeit his or her prize and an alternate winner may be selected.
